**ORDER**

In exercise of the powers conferred by rule 13 of the Aircraft Rules, 1937, the Director General of Civil Aviation hereby permits bonafide passengers traveling in an aircraft engaged in scheduled air transport services to take photographs from inside such an aircraft while in flight and while landing, take off and on ground at civil aerodromes.

This permission is, however, not applicable when such aircraft is landing, taking off or on ground at a defence aerodrome.

- (i) सिविल विमान क्षेत्र; और
- (ii) रक्षा विमान क्षेत्रों पर सिविल अंतःक्षेत्र।

ORDER

New Delhi, the 9th December, 2004

S.O. 1353(E).—In exercise of the powers conferred by proviso to rule 13 of the Aircraft Rules, 1937 and in supersession of the Order of the Government of India in the Ministry of Civil Aviation (Directorate General of Civil Aviation), published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), dated the 25th August, 2003, vide, notification number S.O. 967(E), dated the 25th August, 2003, the Director General of Civil Aviation hereby directs that the restrictions on photography at a Government aerodrome as specified in rule 13 of the said rules shall not apply to the terminal buildings of—

- (i) Civil aerodromes; and
- (ii) Civil enclaves at defence aerodromes.
